APPENDIX A**TECH AREA RULES AND REGULATIONS**

- Crankworx Innsbruck 2021 does not take any liability for stolen or damaged items.
- For the Crankworx Innsbruck 2021, the tech area is organised by ITS GmbH.
- These rules define the conditions in which the ITS GmbH organizes and operates the tech area. It specifies the obligations and the rights of the company/team and of the organizer. The company/team formally commits to respecting these rules.
- The tech area will take place in Mutters from June 16th – June 20th, 2021. The organizer can also decide to prolong the event, postpone or shorten it. In any of these circumstances the company/team will not be entitled to any compensation. If new dates are issued and are not approved by the company/team, the amounts already paid will not be reimbursed.
- There is no exclusivity guaranteed with respect to company/team products.
- Payment must be received in full before the company/team may set up their tech area space.
- In the event that any portion of the tech area is cancelled for any reasons beyond the control of the organizers, neither party shall have any further obligations or liabilities to the other, no compensation or indemnity can be requested nor shall any payments be returned. There will be no refunds due to inclement of weather.
- Completely filled and signed application forms must be returned to the ITS GmbH. Applications can only be taken into consideration as long as tech area space is available. The ITS GmbH has the right to accept or refuse any application and freely assign the location of the booth.
- The application has to be submitted latest until 6th, June 2021.
- Terms of cancellation: Free cancellation before 6th, June 2021.
100 % cancellation fee non-refundable after cancellation by 6th, June 2021. The organizer must be notified in writing of any cancellation.
- Teams who fail to set up their space within the defined load-in hours will forfeit their space with no refund.
- The company/team commits to not remove its booth and tent before the defined Load-Out hours.
- It is strictly forbidden for the company/team to transfer parts or the entire booth to anybody else. Only the entitled company/team can occupy the reserved space. The company/team commits to:
 - only displaying products or services that are related to the company/team's brand.
 - not advertising anything that may be misleading or constitute unfair competition.
- The amount of signage used is to be mutually determined by the company/team and the ITS GmbH. The ITS GmbH reserves the right to remove excessive signage at its own discretion.
- Any onsite activations outside of regular tech booth activities have to be pre-approved by the event organizers.
- The Tech Area is NO Expo Space. No sales whatsoever are allowed in this area.
- Any sampling, give-aways or other commercial activity has to be approved by the organizers prior to the setup of the tech area and is restricted to the location of the designated area space.
- The company/team is solely responsible to comply with any legal restrictions imposed by Austrian law regarding onsite activities.
- Company/team parking is not available on site, except for the above registered vehicles. Registered vehicles will receive a parking permit that has to be visible at all times. The company/team cannot park any non-registered vehicles anywhere in the tech area. An event-parking site in walking distance to the tech area will be available for additional cars.

- The company/team shall be solely responsible for the timely clean up after completion of the festival as well as ongoing clean-up of the booth. This includes having sufficient garbage/recycling bins at each site. Garbage and recycling must be removed from the sites each day. A central garbage disposal location will be provided by the organizer.
- Open fire in the whole festival area (including tech area) is strictly prohibited. Any contravention is a cause for exclusion from the festival.
- The company/team displays all products AT THEIR OWN RISK; please do not leave any valuables unattended. The event organizers assume no liability or responsibility for damage, theft or loss of company/team product or equipment.
- Night + day security will be available for the general event area. **There will NOT be a specific security dedicated to your space watching after your belongings!**
- The ITS GmbH being the organizer of the tech area “Crankworx Innsbruck 2021”, is liable under civil law. This responsibility does not cover any damage caused by third parties to visitors or teams or by company/team to visitors and third parties.

NOTE: the company/team has to insure his booth against theft, damage caused by water, fire, wind. The organizer is not liable for any of these instances. The company/team will be responsible for any damage caused by its staff or from the set-up of the booth. The company/team must have public liability insurance and has to provide the organizer with a copy of it when they apply.

- The ITS GmbH has the right to rule on all instances not covered by these rules and regulations, and to add or modify them. If such an instance were to take place, the ITS GmbH has the right to immediately enforce any new or modified rules or regulations. The memorandum sent to the company/team subsequently will be part of this signed document.
- All transgressions from the rules and regulations can lead to the eviction from the exhibition without notice given to the infringing company/team. Any payments made will not be reimbursed. The ITS GmbH will be allowed to use the freed up area as it wishes.
- All instructions by LOC and security personnel are to be followed, otherwise elimination from the tech area venue will occur.
- By signing the application form, the company/team accepts with, no reserve, the rules and regulations previously mentioned. Only the English original version of the rules and regulations will be admissible in court. The company/team commits to notify the ITS GmbH in writing prior to any legal proceedings. In the case of any legal proceedings, only Austrian law will be applicable and the court of Innsbruck will be the only court competent to deal with the affair.
- COVID-19 restrictions and rules which are prescribed by the Austrian government for the period of the event (June 16th – June 20th, 2021) will be fully accepted and implemented by the organizer.
- The latest regulations will be announced shortly before the event. By participating at Crankworx Innsbruck 2021, the participant agrees to fully comply with all COVID-19 restrictions and rules in place.
